Dear Mr. Salas:

At the August 2019 meeting, the Accrediting Commission of Career Schools and Colleges ("ACCSC" or "the Commission") considered its previous decision to defer final action on the following submitted by Institute of Technology located in Modesto, California:

- Application for Renewal of Accreditation;
- Application for an Unrelated New Program in Vocational Nursing (Diploma); and
- Outcomes Report.

Upon review of the April 18, 2019 Commission letter and the school's response, the Commission:

- Voted to grant Institute of Technology Renewal of Accreditation with Reporting;
- Voted to Accept the Outcomes Report and place the school on Heighted Monitoring; and
- Concluded the school has met the requirements for the addition of the Vocational Nursing (Diploma) program within the school's scope of accreditation.

The Commission's action renews the school's accreditation for a period of four (4) years going forward from June 2018.¹

The mark of an accredited school is its commitment to continuous compliance with accrediting standards. Accordingly, the Commission has included an ACCSC Reporting Enclosure with this letter, which requires Institute of Technology to submit an interim report on its continued compliance with the Commission's standards as noted therein. The Commission also has included an ACCSC Institutional Enhancement Enclosure with this letter, which lists suggestions deserving the school's immediate attention and action.

Also included with this letter is an ACCSC Approved Program Enclosure as documentation of the Institute of Technology's approved programs. Although ACCSC accreditation is institutional in nature, all programs offered by Institute of Technology must be approved by the Commission. Institute of Technology will find the Commission's requirements for the addition of new programs and modifications to existing programs in the *Standards of Accreditation*.

In accordance with this action, the Commission will send the Certificate of Accreditation for Institute of Technology under separate cover. Through the renewal of accreditation, Institute of Technology has continued its partnership with other educators who are committed to providing programs of quality and to conducting their affairs with integrity. The Commission is confident that Institute of Technology will take this responsibility seriously with consideration for the many other ACCSC-accredited institutions that have embraced accreditation as a means to enhance student learning and achieve educational goals.

The Commission previously granted Institute of Technology renewal of accreditation for five (5) years effective June 2013. Therefore, the school's accreditation is effective for a period of four (4) years going forward from June 2018.
