The Commission's action was based upon its review of the institution's application for reaccreditation, the on-site visit team report (visit conducted October 22-23, 2019) and the institution's response to the report, received November 21, 2019.

The Accrediting Commission commends the institution for its efforts toward meeting the Standards for Accreditation reflected in the on-site evaluation team reports. Further, the Commission found that the areas of weakness cited in the team report were substantively addressed in the institution's response to the report and expresses its confidence that the institution will continue to review, monitor, and enhance its operations to assure the high quality of education and training toward which we all strive.

Additionally, the Commission directed the institution to provide a follow-up report for staff review, as follows:

The institution provided a narrative for the Medical Office Administration Billing and Coding completion and placement weakness; however, it did not include an updated Document 28.1 – Completion and Placement Statistics, Document 28.2 – On-Site Sampling Verification Form, and supporting documentation to verify the additional completion and placement statistics fir the MOABC program.

Therefore, the institution is directed to provide a narrative update for staff review to include ACCET Document 28.1, 28.2, and all supporting documentation for the Medical Office Administration Billing and Coding program for the time period January 1 – December 31, 2019. In addition, the institution is directed to provide updated information

regarding the teach out of the Nursing Assistant program.
