Dear Mr. Herberger:

At the May 2023 meeting, the Accrediting Commission of Career Schools and Colleges (“ACCSC” or “the Commission”) considered the following submitted by Institute of Technology located in Redding, California:

- Application for Renewal of Accreditation (Corresponding On-Site Evaluation);
- Application for Initial Distance Education;
- Application for an Academic Associate Degree Program – Physical Therapist Assistant (AAS); and
- Application for an Unrelated Non-Degree Program – Nursing Assistant (Diploma).

Upon review of the March 19, 2023 On-site Evaluation Report and the school’s response to that report, the Commission voted to grant Institute of Technology **Renewal of Accreditation with Reporting**. The Commission’s action renews the school’s accreditation for a period of five (5) years going forward from May 2021.<sup>1</sup> Additionally, the Commission determined that Institute of Technology has met the requirements for initial distance education, degree program in Physical Therapist Assistant (AAS), and unrelated non-degree program in Nursing Assistant (Diploma) as required by accrediting standards.

The mark of an accredited school is its commitment to continuous compliance with accrediting standards. Accordingly, the Commission has included an ACCSC Reporting Enclosure with this letter which requires Institute of Technology to submit an interim report on its continued compliance with the Commission’s standards as noted therein.

Also included with this letter is an ACCSC Approved Program Enclosure as documentation of the school’s approved programs. Although ACCSC accreditation is institutional in nature, all programs offered by the school must be approved by the Commission. Institute of Technology will find the Commission’s requirements for the addition of new programs and modifications to existing programs in the *Standards of Accreditation*.

In accordance with this action, the Commission is enclosing a copy of the school’s Certificate of Accreditation. Through the renewal of accreditation, Institute of Technology has continued its partnership with other educators who are committed to providing programs of quality and to conducting their affairs with integrity. The Commission is confident that the school will take this responsibility seriously with consideration for the many other ACCSC-accredited institutions that have embraced accreditation as a means to enhance student learning and achieve educational goals.

<sup>1</sup> The Commission previously granted Institute of Technology renewal of accreditation for five (5) years effective May 2016. Therefore, the school’s accreditation is effective for a period of five (5) years going forward from May 2021.
